

12P. PLANNING SERVICES - Lane Widening Policy

Resolution of Council (17/12) December 1996

That pursuant to Part 3, Section 27 of the Roads Act 1993 (variation and revocation of lane widening orders) road widening by previous orders (Plan G10-2205 Folio 2791 gazetted 22nd May 1981, Plan G9-2205 Folio 5531 gazetted 24th October 1980, Plan G8-2205 gazetted 28th September 1979, Plan G15-2205 Folio 2729 gazetted 14th June 1985, Plan G13-2205 Folio 2737 gazetted June 1983 and Plan 12-2205 Folio 3643 gazetted 25th July 1986) affecting land fronting the western and eastern sides of Manns Lane and Healeys Lane from Meade Street to Lang Street (Sections 17, 12 and 5) and Ferguson Street to Wentworth Street (Section 23, 18 and 11) respectively be revoked.

Resolved that properties referred to in the Schedule hereunder be excluded from the operation of previous road widening orders.

At the intersection of Healeys Lane and Lang Street, the properties described as Lot B of Deposited Plan 382325 and Lot 20 of Deposited Plan 312823.

At the intersection of Manns Lane and Herbert Street, the properties described as Lot A of Deposited Plan 346037 and Lot 1 of Deposited Plan 371270.
